- He/She also acknowledges that OMB Valves' group companies have adopted their own Organizational, Management and Control models;
- E) the Company has given and implemented instructions to its directors, employees and/or agents aimed at preventing the commission or the attempt of any offence under the "1997 OECD Convention on Combating Bribery of Foreign Public Officials in International Business Transactions" (the OECD Convention"), the United Nations Convention Against Corruption and any applicable anti-corruption laws (for instance, the Italian Legislative Decree N. 231 of 8 June 2001, the U.S. Foreign Corrupt Practices Act or any other anti-bribery laws, as the case may be). Furthermore, the Company undertakes OMB Valves to continue effectively implementing such instructions for the entire duration of this business relationship;
- F) all the employees of the Company are regularly mentioned on the "Pay Roll" or all equivalent documents as requested by the corresponding national applicable law and all the obligations with regards to contributions and insurance have been fulfilled by the Company;
- G) the Company is familiar with and understands the provisions of the anti-bribery and anti-corruption laws of the countries in which it performs the order. The Company declares that it has not engaged and will not engage in any conduct that violates the provisions of the anti-bribery and anti corruption laws of these countries, and shall abide by such legislation while performing any business. Neither the vendor neither any person acting for or on behalf of the Company shall offer, promise, arrange for or pay, either directly or indirectly, anything of value to "any government official" or any other person for the purpose of obtaining any improper advantage.
- H) to have received the OMB Valves informative for the treatment of personal data in accordance with Italian Legislative Decree No. 196 dated 30 June 2003 (that implements in Italy the European Union Directive 95/46/EC);
- I) If so requested by OMB Valves, the Company shall promptly provide information concerning its control structure (including the identity of its shareholders and their relevant stakes). In the event of Trust(s) and/or fiduciary registration, however established, the Company shall also provide the identity of the relevant grantor(s), and its/their respective stake(s).
